CONTRACT TO RECEIVE A CONTRIBUTION FROM AN ENDOWMENT FUND

Parties

Endowment Fund of Palacký University, Olomouc

(hereinafter referred to as the "Provider")

and

(hereinafter referred to as the "Recipient")

hereby enter, under Section 1746 (2) of Act No. 89/2012 Sb., the Civil Code (hereinafter referred to as the "Civil Code") into the following contract to receive a contribution from an endowment fund (hereinafter the "Contract"):

I

Introductory Provisions

1. The Recipient is a student of Palacký University, Olomouc, in year of study, programme of study: , field of study: , implemented by faculty
2. At its meeting of the Board of Directors decided to grant a contribution in the amount of (hereinafter the "Contribution") to the Recipient.
3. The Contribution has been granted on the basis of Article VI (1) of the Provider's Constitution for the following reasons:

II

Requirements to Receive the Contribution

1. The Contribution is granted to cover the costs related to the implementation of a project entitled

and the Recipient agrees to use the contribution only to cover the costs related to the implementation of the project in line with the budget which is an integral part hereof constituting Annex No. 1.
2. If the Recipient does not use the contribution in full, he or she agrees to return the part that has not been used to the Provider, within 14 days after the final accounts have been submitted.
3. Within 1 months after the expiry of the term hereof, the Recipient agrees to submit to the Provider a report on the implementation of the project and its results; a prescribed form for the report is available on the website of the Provider. Together with the report, the Recipient shall provide the Provider with a minimum of 5 photographs showing the implementation of the supported activity. The Recipient grants to the Provider a non-exclusive gratuitous license with an unlimited temporal and territorial scope to any uses of the photographs, including but not limited to the promotion of the Provider's activities.
4. The Recipient agrees to cooperate with the Provider in order to promote the activities supported by the Provider in media, for example by giving an interview or helping prepare an article about the implementation of the project.
5. At any time during the term hereof and after the expiry hereof, the Recipient agrees to submit to the Provider accounts of how the contribution has been used within 1 month after he or she has been requested to do so by the Provider; a plain copy of relevant documents shall be attached to the accounts.

III

Payment of the Contribution

The Contribution shall be paid within 14 days of the date hereof

IV

Withdrawal of the Contribution

1. The Board of Directors Committee of the Provider may decide to withdraw the Contribution in full or in part if the requirements stipulated herein or in the Constitution of the Provider are violated.
2. The situations that may be considered by the Board of Directors of the Provider to constitute a violation qualifying for a withdrawal of the contribution include but are not limited to the following:
 - a) providing false information in the application for the contribution;
 - b) using the contribution contrary to Article II hereof;
 - c) failure to provide accounts and relevant documents under Article II (4) hereof;
 - d) committing a disciplinary infraction under internal regulations of Palacký University, Olomouc, or a crime;
 - e) termination of study at Palacký University, Olomouc during the term hereof.
3. If the Board of Directors of the Provider decides to withdraw the contribution in part or in full, the Recipient agrees to return the contribution within 14 days of the receipt of the respective decision.

V
Final Provisions

1. This Contract is entered into for a fixed term terminating on ;
however, this Contract shall terminate as soon as the Recipient ceases to be a student of Palacký University, Olomouc, and it is at the discretion of the Board of Directors whether it will require that the Recipient return the contribution in full or in part.
2. The rights and obligations not expressly regulated herein shall be governed by the laws of the Czech Republic, in particular by the relevant provisions of the Civil Code.
3. This Contract may only be amended by means of written serially numbered amendments signed by both Parties.
4. By signing hereof, the Parties declare that this Contract is an expression of their true will and that this Contract has not been signed under duress or clearly disadvantageous conditions.
5. This Contract is drawn up in 3 counterparts, of which the Provider shall receive 2 and the Recipient 1.
